Dear residents and community members,

On Monday, January 8, 2017, Taraval Station hosted a press conference to announce the department’s plan to address the increase in auto burglaries. In 2017, the reported number of auto burglaries increased 24% to approximately 30,000 citywide.

The Taraval District was not immune and the number of reported auto burglaries in the district increased 10% to 1,783 in 2017. A review of the December 2017 auto burglary statistics revealed that property was left in plain-view 70% of the time. Items of significant value were left in vehicles 90% of the time. In 75% of the incidents, the property taken was valued in excess of \$950.00.

Please remember to “Park Smart” and take all of your valuables with you, including wallets, passports, cell phones, tablets, laptops and cameras. Auto burglaries happen in seconds and it is difficult apprehending subjects that are involved.

Taraval Station will continue to take a pro-active approach. We will be conducting enforcement operations and an educational outreach program to address the increase in auto burglaries.

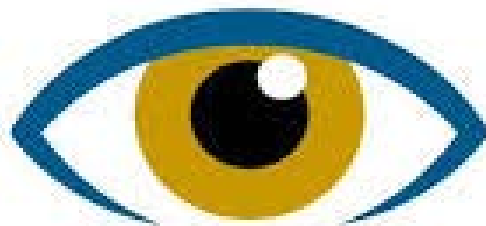


Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ◆ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages or individuals following delivery trucks to see where the truck is dropping off packages.
- ◆ Please dial 911 to report crimes in progress, suspicious activity or for life threatening emergencies. If it is not an emergency, dial (415) 553-0123.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Taraval Station has two officers that coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Taraval Station has 3 foot beat locations. These officers are assigned to Irving St, West Portal Ave and Ocean Ave.
- Monthly Police Community Relations Meetings: Community Meetings are going to be held continuously. Officers and sergeants also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Taraval Station will send out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



Definition of Crimes

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, couple with the present ability, to commit a violent injury on another person.

Battery – (**Misdemeanor Battery**) is any willful and unlawful touching of another.

(**Felony Battery**) is the use of force or violence up the person of another that causes serious bodily injuries.

*Assault is when a person swings their arm at a person and battery is when that arm makes contact with the person.

Aggravated Assault- Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent to enter a property to commit a grand theft, petty, theft or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken that exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

Traffic Violations

22450(a) CVC The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection **shall stop at a limit line**, if marked, otherwise before entering the crosswalk on the near side of the intersection.

21450(a) CVC The driver of any vehicle approaching a **stop sign** at the entrance to, or within, an intersection shall **stop** at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection.

22350 CVC No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the **traffic** on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

21950(a) CVC The driver of a vehicle shall **yield** the right-of-way to a **pedestrian** crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection, except as otherwise provided in this chapter.

21801(a) CVC The driver of a vehicle intending to turn to the left or to complete a U-turn upon a highway, or to turn left into public or private property, or an alley, shall yield the right-of-way to all vehicles approaching from the opposite direction which are close enough to constitute a hazard at any time during the turning movement, and shall continue to yield the right-of-way to the approaching vehicles until the left turn or U-turn can be made with reasonable safety.

Shoplifting with Force – Malicious Mischief – Arrested

Officers responded to a report of a combative suspect who was being detained by a Loss Prevention employee. The victims reported that the two suspects appeared to be shopping inside a Macy's store but had placed multiple items of merchandise into their bags before exiting the store without paying. The victims attempted to detain the suspects but the suspects swung their arms about in a violent manner. The victims were successful in placing one of the suspects in handcuffs and escorted her to the security office. During the process, the detained suspect made multiple verbal threats to kill the victims while the second suspect began to follow them and throwing merchandise at the victims. Once in the office, the detained suspect damaged furniture and property by aggressively kicking at them. Responding officers arrived and detained the second suspect. After further investigation, **both suspects were arrested.**

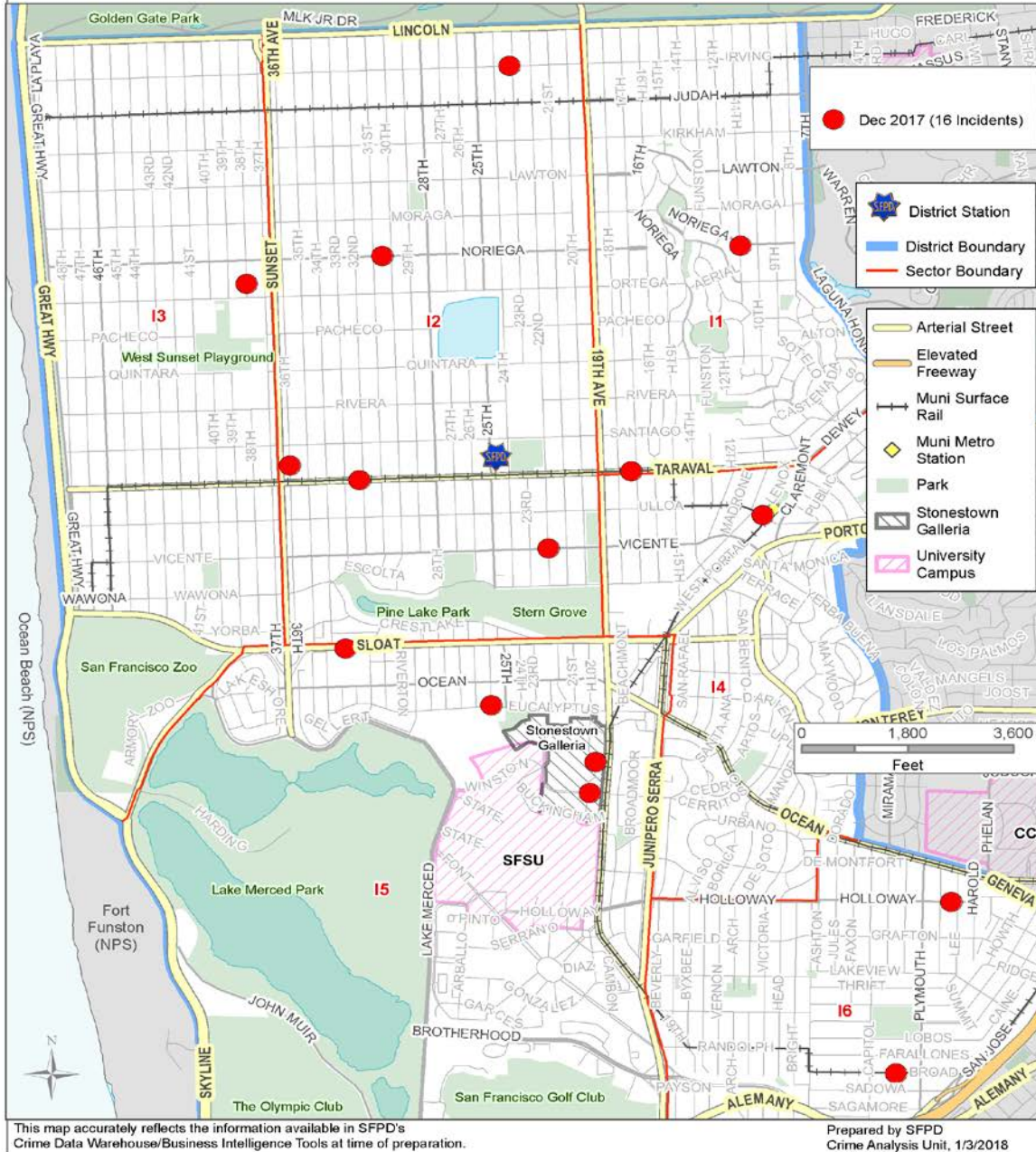

Robbery, Taraval District December 2017 (16 Incidents)

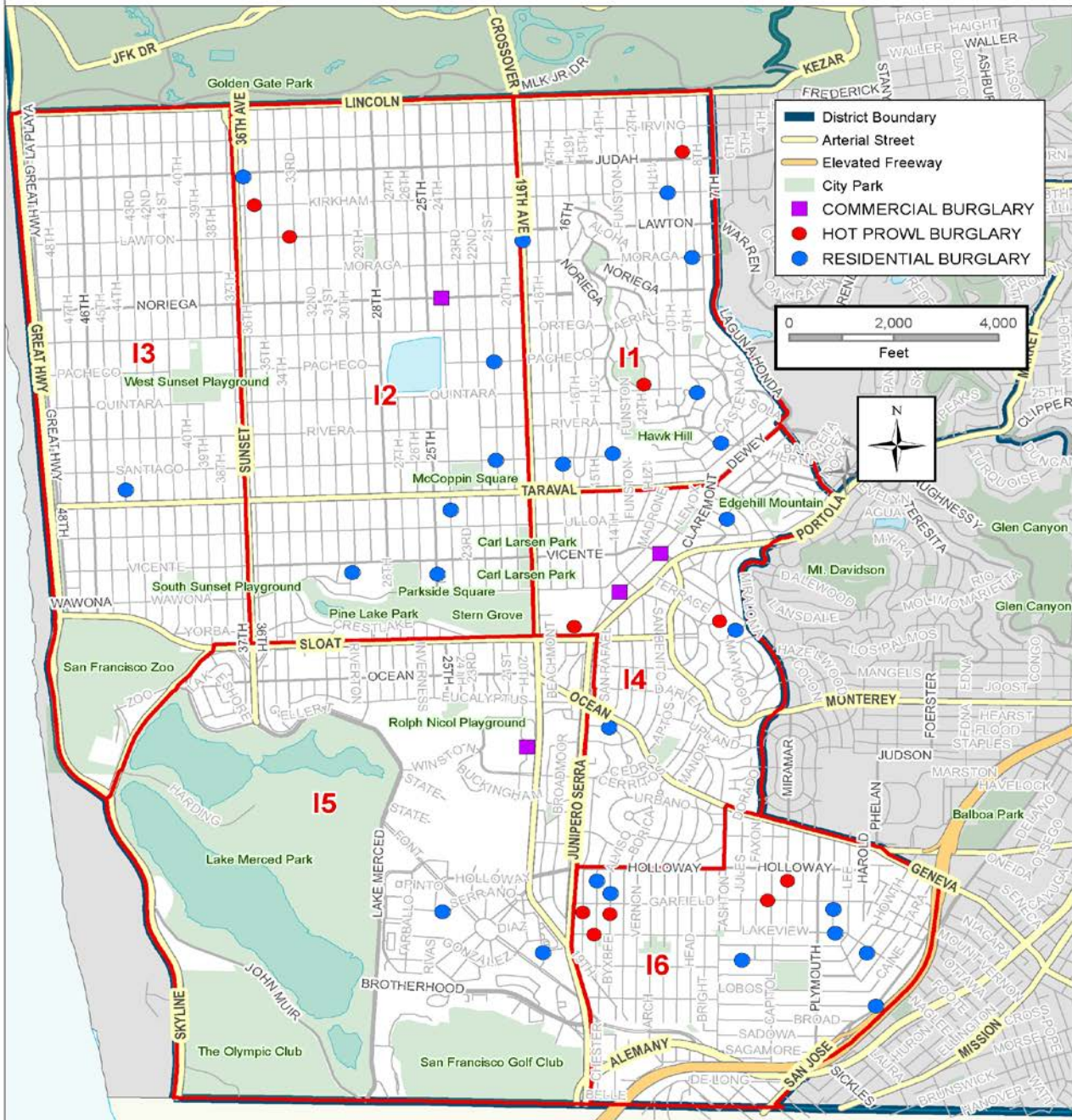

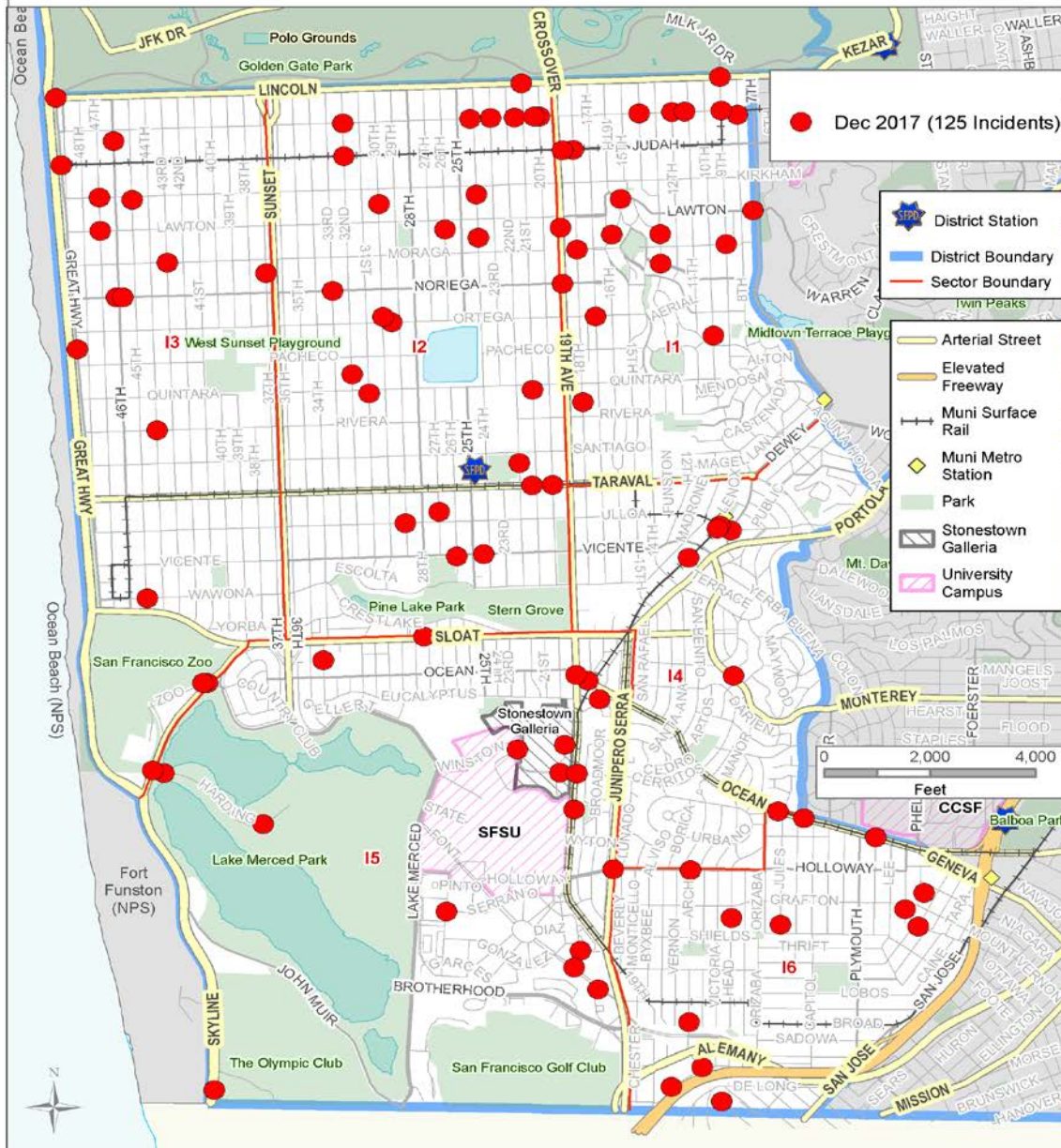

Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on January 4th, 8th, 10th and 30th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

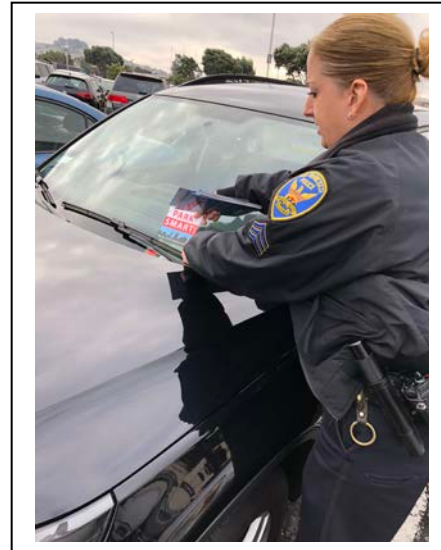

San Francisco Tips

Dress in layers - San Francisco has several microclimates that can change the temperature by 10 degrees from block to block.

To ensure cyclists' safety, check your surroundings before opening car doors, making right turns and crossing the street. If you will be biking please note that it is unlawful for bikes to travel on the sidewalks in San Francisco.

Take a reusable bag when you go shopping to avoid a .10¢ per bag fee.

A Muni Visitor Pass can be purchased for 1, 3, or 7 consecutive days of unlimited rides on Muni, Muni Metro, historic streetcars and cable cars. They can be purchased at most Walgreens in the city, the San Francisco Visitor Information Center at 900 Market Street and the cable car kiosks.

Every Tuesday at noon San Francisco tests the Outdoor Warning System that emits a 15 second alert tone. If you hear the sirens at any other time go indoors immediately.

When parking on one of San Francisco's famous hills make sure to **curb your wheels**. Turn the tires toward the street when facing uphill and toward the curb when facing downhill to use the curb as a block.

Do not pass stopped cable cars or streetcars.

Be alert, particularly in crowded situations. Staged distractions are a favorite ploy of pickpockets.

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.

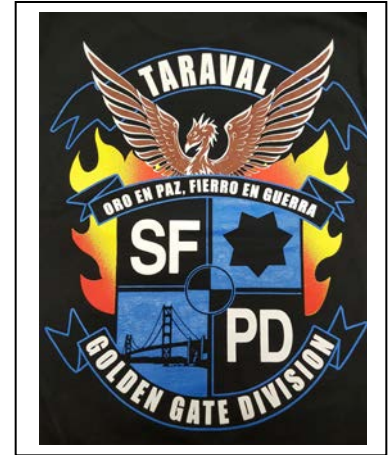
