SFPD Holiday Toy Drive

The San Francisco Police Department launched its 2018 Holiday Toy Drive, benefiting the City's children in need.

From November 16 to December 14, SFPD will be accepting donations of new, unwrapped toys at more than 60 San Francisco Walgreens locations. The goal is to exceed last year's toy drive, in which approximately 9,000 items were donated at Walgreens stores for distribution to San Francisco children.

"Something as simple as a toy can stir a child's imagination and bring joy to youth in need," said San Francisco Police Chief William Scott. "Please give generously to make this holiday season brighter for our City's children."

Safe Shopper - Holiday Season Safety Tips

During this holiday season, the Police Department will be working to enhance safety for residents, visitors, and shoppers. There will be increased foot patrols to shopping areas throughout the city, including the horse/mounted unit, plain clothes officers, and traffic enforcement.

"The men and women of the San Francisco Police Department wish everyone a safe and joyful holiday season. Whether you're shopping for gifts or going about your daily routine, it's important to remain careful and aware to prevent theft. Follow our tips to help keep you and your belongings safe."

- Stay alert when using electronic devices. Limit your distractions.
- Always be alert to your surroundings and have your keys in your hand as you approach your vehicle.
- Park Smart: Help avoid vehicle break-ins, leave nothing visible in your car. Consider moving your vehicle to a different location each time you load packages in the trunk. Try to use parking lots where there are parking attendants.
- Keep your wallet in a hard-to-reach place and carry only the cash and credit cards that you will need to complete your shopping.
- If someone demands your purse, wallet, or packages, surrender them, make note of the suspect's description and direction they flee and call 911. Property can be replaced.
- "If you see something, say something." If you witness criminal activity or see something or someone suspicious, flag down a police officer, call 911 or contact security.
- Use 311 to report auto burglaries.
- Shop with a companion, especially after dark, whenever possible.
- Shield your PIN when using ATMs or other electronic devices in public.

The suspect, who was known to the officers, was located and detained. After further investigation, the suspect was arrested.

Officers responded to a report of a robbery. The victim reported that he and his friends were standing near the swings in a playground when they were approached by three suspects. One of the suspects demanded the victims' property, which the victims fearfully handed to the suspect. Immediately afterwards, all three suspects fled the area.

Officers responded to a battery. The victim, a shop keeper, stated that the suspect had picked out and purchased flowers. However, after the flowers had been cut and wrapped, the suspect then stated that the flowers were not to his liking and asked for a discount after paying for them. The victim declined to give a discount and the suspect responded by selected another bundle of flowers and walked away with them instead. The victim attempted to stop the suspect but was pushed away. The suspect then fled the area.

Warrant Arrest - Arrested

Officers responded to a report of a suspect who was stealing packages in the neighborhood. The witness reported that he had observed the suspect steal a package from a doorstep, confronted the suspect and retrieved the package. Responding officers located and detained the suspect. A computer check on the suspect revealed two arrest warrants out of San Mateo County. The suspect was arrested.

Officers responded to a report of a burglary in progress. The witness reported that two vehicles had suspiciously parked in front of the gate at the entry of a construction area, which had a recent history of metal thefts. The witness investigated and observed a bolt cutter inside the vehicle and that the gate's chain had also been recently cut. The responding officers started to enter the construction area but were met by two suspects who exited the area with their hands up. The suspects stated that they did not do anything wrong and that they had just come from a nearby McDonalds. After further investigation, the suspects were arrested.

Robbery

Officers responded to a report of a robbery at a gas station. The victim reported that the suspect had entered the station and selected several items of food before taking it to the register. As the victim processed the items for purchase, the suspect suddenly held up a handgun and pointed it at the victim while demanding money. The suspect then immediately fled the area on his motorcycle with the stolen money and food.

Attempted Kidnaping

Officers responded to a report of a possible kidnaping attempt. The victim reported that she was walking home from school when she saw the suspect looking into the trunk of his parked car. As the victim walked past the suspect, the suspect asked the victim if she wanted a ride in the car. The victim refused and the suspect approached her and demanded that she come closer to him. The suspect then attempted to grab the victim's arm but the victim successfully ran away from the suspect. The suspect then entered his vehicle and drove away from the area.

Officers responded to a report of a stolen vehicle. The victim reported that he had stopped to buy a cup of coffee but left his vehicle running before exiting it and going into the store. When the victim returned, the vehicle was missing. The officers questioned the suspect, who denied knowledge of the vehicle. A search of the suspect's backpack located items belonging to the victim. After further investigation, the suspect was arrested.

Officers responded to 7-11 regarding an altercation with a hammer. The witness reported that the suspect was observed causing an commotion inside the store and was asked to leave. The suspect responded angrily and kicked at a glass window, causing it to shatter and break. An employee exited the store and confronted the suspect and asked him to leave but the suspect refused. The employee returned to the store and exited with a hammer, which he used to hit the suspect. After further investigation, both the suspect and the employee were arrested.

Officers responded to a report of an auto burglary. The witness reported that the suspect was observed attempting to open the doors of multiple vehicles that were parked in a parking lot. After further investigation, the suspect was cited.

<u>Traffic Violation – Evading a Police Officer – Resisting Arrest – No License Issued – Arrested</u>

Officers were on patrol and observed a vehicle that did not have a rear license plate. The officers attempted to conduct a traffic stop but the suspect refused to pull over and tried to flee. However, the driver's vehicle hit a dip in the road which caused the vehicle to stop. The driver immediately exited the vehicle and fled on foot. The officers gave chase and with the help of bystanders, the suspect was located and detained. A search of the suspect's vehicle revealed a mask and a window punch. After further investigation, the suspect was arrested.







Beware of Scams

Fake Check Scams

Consumers paid with phony checks for work or for items they're trying to sell, instructed to wire money back to buyer

Prizes/Sweepstakes/Free Gifts

Requests for payment to claim fictitious prizes, lottery winnings, or gifts

Recovery/Refund Companies

Scammers contact victims and claim the consumer owes money on a fictitious debt or to help recover money lost in a previous scam

Advance Fee Loans, Credit Arrangers

False promises of business or personal loans, even if credit is bad, for a fee upfront

Phishing/Spoofing

Emails pretending to be from a well-known source ask consumers to enter or confirm personal information

Computers: Equipment and Software

Scammers claim to offer "technical support" for computer problems and charge a fee to fix a nonexistent problem

Scholarships/Grants

For a fee, a "search company" offers to conduct customized search for scholarships or grants for students. Scammers take money and run or provide a worthless list

Friendship & Sweetheart Swindles

Con artist nurtures an online relationship, builds trust, and convinces victim to send money

Charitable Solicitations

Scammers contact victims claiming to represent non-existent charities (or real charities they don't actually work for) and ask for donations.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages or individuals following delivery trucks to see where the truck is dropping off packages.
- Please dial 911 to report crimes in progress, suspicious activity or for life threatening emergencies. If it is not an emergency, dial (415) 553-0123.



Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

Homeless Outreach and Outreach to Drug Users:

Taraval Station has two officers that coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.

Foot Patrols:

Taraval Station has 3 foot beat locations. These officers are assigned to Irving St, West Portal Ave and Ocean Ave.

Monthly Police Community Relations Meetings:

Community Meetings are going to be held continuously. Officers and sergeants also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving. These meeting will be on the third Tuesday of each month.

Email Updates:

Taraval Station will send out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.
