San Francisco Police Issues Alert on Chinese Gold Scam 19-081



The San Francisco Police Department would like to alert the Asian community about a scam that utilizes fake treasures to swindle victims. In the most recent case, the suspects sought out the victim because he is a business owner and has access to currency. The suspects won the trust of the owner and convinced the victim that they uncovered a treasure trove of "priceless" ancient Chinese artifacts at a construction site. The suspects told the victim the "artifacts" are gold ingots and figurines of Buddha and that they were willing to sell them to the victim at a substantial loss of \$100,000.

The suspects may be using a variation of this story to deceive their victims who are Asian males in their 40's or older and speak Mandarin. One San Francisco victim lost \$67,000. There have been reports of recent scams of this nature in New York and southern California. SFPD is conducting an investigation into the San Francisco incident and is working with outside agencies to try to identify the suspects. Attached is a photo of the fake gold ingots, gold figurines, and Chinese artifacts that the suspect gave to the victim in exchange for money.

This scheme has been used to scam victims throughout the United States and Asia. SFPD is requesting the community to be vigilant in identifying fraud and scams, and report suspicious activity of this nature. If you have purchased gold pieces, we recommend that you have them tested. If you believe you are a victim of this crime, please file a police report with your local police station. Bicycle and Pedestrian Safety Enforcement Operations Plan for San Francisco with OTS Grant 19-080

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on July 1st, 9th, 17th, 25th, and 30th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.



Become A Reserve Officer.



The Police Reserve Officer Program is comprised of community members, such as yourself, and retired police officers who wish to volunteer as a Reserve Police Officer. These officers supplement the full-time officers in a variety of duties throughout the Department. This program is ideal for individuals who have an established career but always wanted to experience being Police Officer. Reserve Officers can enjoy the best of both worlds, maintain their chosen career while helping to police an internationally known city. There will be a Level III Reserve Police Academy starting on September 23, 2019 and it will conclude on December 4th. The Reserve Academy takes place on Mondays and Wednesdays from 6pm to 10pm and all day on Saturdays from 8am to 5pm. The cost for the Academy is 1765.00. This is the minimum requirement to be a Level III Reserve in the state of California. This is a volunteer position with great training opportunities and experiences seldom seen. The Level III Academy is 168 hours long.

Protect Your Vehicle Against Catalytic Converter Theft



Thieves are looking for fuel-powered vehicles manufactured after 1974 that have catalytic converters. Thieves often target taller vehicles (such as pickup trucks or SUVs) because they can easily fit under the vehicle to access the catalytic converter. The location of your car may also be a factor like regularly parking in one area for a long period of time. When possible, park in well-lit areas and close to building entrances. If you have a garage at your house, park your vehicle inside and keep the garage door close.

Have the catalytic converter welded to your car's frame, which may make it harder to steal.

Consider engraving your vehicle identification number (VIN) on the catalytic converter — this may help alert a scrap dealer that it was stolen and make it easier to identify the owner.

Calibrate your car's alarm to set off when it detects vibration.

Protect Your Vehicle from Car Theft

- Never leave your car running or the keys in the ignition when you're away from it, even for "just a minute."
- Always roll up the windows and lock the car, even if it's in front of your home.
- Never leave valuables in plain view, even if your car is locked. Put them in the trunk or at least out of sight.
- Remove portable electronic devices such as smart phones and GPS navigation systems, including suction cup or bean bag type mounts. (Even the visible appearance of a suction cup ring on the glass windshield can be an enticement to a thief to break in and look for the GPS system.)
- Park in busy, well-lighted area.
- Carry the registration and insurance card with you. Don't leave personal identification documents or credit cards in your vehicle.
- When you pay to park in a lot or garage, leave just the ignition or valet key with the attendant. Make sure no personal information is attached. Do the same when you take your car for repairs.
- Install a mechanical locking device commonly called clubs, collars, or j-bars that lock to the steering wheel, column, or brake to prevent the wheel from being turned more than a few degrees. Use it!
- Investigate in security systems. You may get a discount on your auto insurance.



Taraval Community Members, We are seeing an increase in burglaries targeting homes that are under construction. In these incidents, suspects would break into the building or construction sites and steal numerous high end construction equipment. Currently, if your home is under construction and no one is at that location after work hours, please call Taraval Station at 415-759-3100 and provide your name and the address of the construction site and phone number. We can have our officers conduct passing calls.

Burglary Awareness & Prevention Tips for Construction Sites



Securing & Preventing

- 1. Secure all equipment and vehicles at all times.
- 2. Take effort to reduce the visibility of tools and equipment secured in vehicles or on job sites.
- 3. Make use of adequate lighting in conjunction with open chain-link fencing on the perimeter to allow for high visibility to the job site.
- 4. Strongly consider the use of security systems such as alarms and video surveillance. Ensure signage for such is clearly visible.

Precautionary Measures

- 1. Photograph all tools. Ensure photographs clearly show the associated serial number and/or distinctive markings.
- 2. Ensure job site keys are marked "Do Not Duplicate" and are controlled at all times.
- 3. Attempt to park employee vehicles within visual range of the job

Should a Burglary Occur

Immediately contact 911. Be prepared to provide the following information:

- a) Time of incident.
- b) Video (if available).
- c) Items taken (include make, model, description, location taken from, value, photos and serial numbers).
- d) Insurance information.
- e) Owner's information.







Beware of Scams

Fake Check Scams

Consumers paid with phony checks for work or for items they're trying to sell, instructed to wire money back to buyer

Prizes/Sweepstakes/Free Gifts

Requests for payment to claim fictitious prizes, lottery winnings, or gifts

Recovery/Refund Companies

Scammers contact victims and claim the consumer owes money on a fictitious debt or to help recover money lost in a previous scam

Advance Fee Loans, Credit Arrangers

False promises of business or personal loans, even if credit is bad, for a fee upfront

Phishing/Spoofing

Emails pretending to be from a well-known source ask consumers to enter or confirm personal information

Computers: Equipment and Software

Scammers claim to offer "technical support" for computer problems and charge a fee to fix a nonexistent problem

Scholarships/Grants

For a fee, a "search company" offers to conduct customized search for scholarships or grants for students. Scammers take money and run or provide a worthless list

Friendship & Sweetheart Swindles

Con artist nurtures an online relationship, builds trust, and convinces victim to send money

Charitable Solicitations

Scammers contact victims claiming to represent non-existent charities (or real charities they don't actually work for) and ask for donations.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages or individuals following delivery trucks to see where the truck is dropping off packages.
- Please dial 911 to report crimes in progress, suspicious activity or for life threatening emergencies. If it is not an emergency, dial (415) 553-0123.



Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

Homeless Outreach and Outreach to Drug Users:

Taraval Station has two officers that coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.

Foot Patrols:


