We have had some terrible accidents throughout The City as of late so expect to see stepped up enforcement not only in the Taraval but Citywide. We had a bad accident on John Muir Drive recently where a mother and her daughter were hit by a car while crossing the street in a pedestrian crosswalk. It is with a very heavy heart that I sadly report that the 14 year old girl did not survive the accident. I have been a Police Officer for over 25 years and it always hits me hard when children are hurt, I have kids of my own and my mind always wanders to them and I feel deep sympathy for the loss of any child. The Officers from Taraval Station that were the first responders to the scene were also deeply affected. I also feel bad for the driver as they did not mean for this to happen and now they have to live with the tragic reality. It is even hard for me to write this but I have to, if my message to the community saves a life we all are better off. I know in my last column I reference the old saying of "it's not worth it" if something happened while not driving safely or being distracted but it really is true so please take it to heart.

It's a bit hard for me to transition out of my last message but I do want to share more information with everyone including our latest crime stats. Taraval Station Officers continue to do a good job in an effort to reduce home and auto burglaries. Auto burglaries dropped from 161 in January to 123 in February, a 24% decrease and from 123 in February to 80 in March, a 35% decrease. Home burglaries dropped from 28 in January to 23 in February, an 18% decrease and from 23 in February to 19 in March, a 17% decrease. Taraval Station Officers as well as the Taraval Neighborhood Team, TNT, continue to work with our Burglary and Robbery Units. They share information, work together, learn from each other to get better and they are making a difference.

In a recent joint operation between Taraval Station and Richmond Station I loaned our TNT crew to work with Captain Michelle Jeans' plainclothes crew. The joint operation was quickly on the trail of a trio of auto burglars and the team of Officers effectively worked together and displayed great teamwork and tenacity as they never lost the "eye" and observed the trio casing several vehicle and then they quickly hit and broke into a vehicle. The team was able to safely and stealthily follow the auto burglars and eventually effected a traffic stop on the felonious few. So as the investigation unfolds two youngsters an 18 year old and a 19 year old are driving around a 12 year old and sending him out to break into cars. Can you believe it 12 years old! Wow that's a new one on me. We will see how this plays out in court.

As I close I again have to go back to my message of safe driving. I had a recent conversation with the President of the Board of Supervisors Norman Yee in which Supervisor Yee said "we have to change our culture of driving too fast or distracted". I could not agree more. We need to focus more on personal safety and driving a safe speed. Enforcement alone is not enough.



Burglary Awareness & Prevention Tips for Construction Sites



Securing & Preventing

1. Secure all equipment and vehicles at all times.
2. Take effort to reduce the visibility of tools and equipment secured in vehicles or on job sites.
3. Make use of adequate lighting in conjunction with open chain-link fencing on the perimeter to allow for high visibility to the job site.
4. Strongly consider the use of security systems such as alarms and video surveillance. Ensure signage for such is clearly visible.

Precautionary Measures

1. Photograph all tools. Ensure photographs clearly show the associated serial number and/or distinctive markings.
2. Ensure job site keys are marked "Do Not Duplicate" and are controlled at all times.
3. Attempt to park employee vehicles within visual range of the job site.

Should a Burglary Occur

- Immediately contact 911. Be prepared to provide the following information:
- a) Time of incident.
 - b) Video (if available).
 - c) Items taken (include make, model, description, location taken from, value, photos and serial numbers).
 - d) Insurance information.
 - e) Owner's information.

Construction Site Burglaries & Thefts

Construction site burglaries and thefts are a common and costly occurrence in San Francisco. Valuable time and money are lost when equipment and materials are stolen from a worksite or vehicle. Consider the following suggestions to reduce your risk of being victimized:

- Plan the site security well in advance.
- Network with law enforcement, contact the local district police station to provide work site location and work hours.
- Notify the surrounding neighbors by providing them with a "Courtesy Note" asking them to report any suspicious activity or crime immediately to the police. Provide them with additional emergency contact information and work hours.
- Lighting is a good crime deterrent. Prepare the site for additional lighting around the perimeter.
- Inventory, engrave or mark your tools for recovery. Tools and equipment should be inscribed with your CA driver's license number. This will help police locate the owner of recovered tools or equipment and help with testimony at a trial. Materials and equipment should be secured in a cargo container for storage if not removed from the work site.
- Construction site doors and windows should be secured by locks, otherwise fencing or boarding should be erected.
- Good communication between the site supervisor and employees is vital so that doors and windows are not left open or unsecured at the end of the workday. Provide employees with written instructions on security expectations. It should be the responsibility of the Construction Supervisor to lock up the site.
- Screen your employees. Employees should wear visible identification. Never assume someone on site is a construction worker.
- Avoid leaving equipment vehicles at an unattended worksite.
- Secure portable toilet door with a padlock.

San Francisco Police Make Arrests in Illegal Cultivation & Money Laundering Investigation

In December 2018, officers at SFPD's Taraval Station began an investigation into illegal marijuana cultivation conspiracy, money laundering and possible human trafficking in the Taraval and Ingleside Police Districts.

On the morning of February 21, 2019 the Taraval Neighborhood Team (TNT), the SFPD Narcotics Detail, and the SFPD Special Victims Unit served seven simultaneous search warrants that resulted in the seizure of evidence from the following locations:

- 840 marijuana plants- 200 block of 40th Avenue
- 900 marijuana plants and 12 lbs. of wrapped marijuana in a suitcase- 3400 block of Judah Street
- 1,237 marijuana plants and \$11,000 in U.S. currency- 1900 block of 45th Avenue
- 435 marijuana plants- 2500 block of Ocean Avenue
- Financial information related to the operation- 200 block of Summit Way
- Financial information related to the criminal conspiracy seized- 4000 block of Alemany Boulevard

A total of 3,412 marijuana plants were seized in addition to three vehicles used in the criminal conspiracy. The investigation unearthed numerous fire code violations as the marijuana grow houses were found to have illegal electrical infrastructures, creating a fire hazard for the surrounding community.

The financial information seized from the above-mentioned locations was indicative of an ongoing money laundering operation used to fund and expand the criminal enterprise.



Officers responded to a battery at Walgreens. The victim reported that she had confronted a known subject, who had a history of shoplifting at the store, and the subject responded angrily by spitting at the victim before exiting the store. Responding officers located the subject and a computer check revealed a warrant for his arrest. **The subject was arrested.**

Assault – Warrant Arrest – Arrested

Officers responded to a report of an assault. The victim stated that he had been playing pool inside a bar when the suspect, who was highly intoxicated, created a scene and was asked to leave the bar. The victim exited the bar behind the suspect and the suspect suddenly struck the victim with a scooter. Responding officers located the suspect and a computer check revealed an arrest warrant from San Mateo County. **The suspect was arrested.**

Assault

Officers responded to a report of an assault. The victim, a driver for Uber, stated that he had just made a right turn when he was almost hit by the suspect who had driven around a bus. The victim responded by honking his horn and making a rude gesture at the suspect. The suspect then followed the victim until he stopped at a stoplight and approached him after exiting her vehicle. The victim fearfully attempted to pepper spray the suspect but failed and the victim drove away from the suspect. The suspect then re entered her vehicle and used it to hit his vehicle before leaving the area.

The victim came to Taraval Station to report an assault. The victim stated that he was at Stern Grove with a friend, the another victim, when a group of suspects assaulted his friend. The victim attempted to help his friend but the suspects turned their attention to him and punched and kicked him before they left. The victim reported that his cell phone was missing after the incident.

Officers responded to a report of a shoplifter who was in custody. The witness, a loss prevention officer, stated that the suspect had been observed putting multiple bottles of beer into his backpack before walking out of the store without paying for them. Responding officers interviewed the suspect, who was detained by the witness, and observed that the suspect was in possession of pills that did not have a description label or prescription attached to them. A computer check revealed that the suspect was on probation. The pills were later identified as a controlled substance. **The suspect was arrested.**

Attempted Robbery

Officers responded to a report of a robbery. The victim stated that he had just gotten off of BART and was walking home when a vehicle passed by him and stopped at the end of the block. The victim then noticed that the suspect had walked up to him and was trying to steal the phone that was in the victim's hands. The suspect knocked the phone onto the ground before fleeing the area.

Officers responded to a report of suspicious activity. Plain clothes officers responded to the location and observed the suspect breaking into two vehicles. The officers detained the suspect and discovered stolen property in the suspect's possession. A computer check revealed that the suspect was on probation for theft. Officers responded to a report of a robbery. The victim, an employee, observed a suspect stealing items from the store and followed the suspect. The suspect suddenly grabbed a bottle and threatened to stab the victim with it before attempting to break the bottle and frighten off the victim. Responding officers located the suspect and detained him. **After further investigation, the suspect was arrested.**

Driver's License Suspended – Warrant Arrest – Arrested

Officers responded to a report of a wanted suspect from the Parole Office who was last tracked as being in the area. Responding officers located the suspect, who was in a vehicle with another person. The officers detained the vehicle and determined that the suspect did not have a valid driver's license. A computer check on the driver also revealed a warrant for her arrest out of Santa Clara. **Both the suspect and the driver were arrested.**

Officers responded to a report of an assault. The victim, a student, told the officers that he was in the playground near the parking lot when another student hit him. However, a school security officer stated that the victim had initially told him that he walked by a group of students and had said something to them. The suspects then angrily pushed the victim and one of them hit the victim on the head with a metal water bottle.

Shooting into a Vehicle

Officers responded to a report of a shooting. San Francisco State Police located a vehicle with its windows shattered but the victim was not very cooperative during the interview and was very vague about the incident. The victim stated that he had been parked when two suspects approached him and asked if he wanted to sell them marijuana. The victim stated that he told the suspects that he didn't and drove away. Shortly afterwards, the victim stated that he heard a gun shot and that his window had shattered. An observation of the interior of the vehicle revealed marijuana and money.

Officers responded to a report of vandalism. The victim, a MUNI driver, stated that he had told the suspect to get off the bus because it was the last stop. Responding officers located the suspect and detained him. After further investigation, the suspect was arrested.







Beware of Scams

Fake Check Scams

Consumers paid with phony checks for work or for items they're trying to sell, instructed to wire money back to buyer

Prizes/Sweepstakes/Free Gifts

Requests for payment to claim fictitious prizes, lottery winnings, or gifts

Recovery/Refund Companies

Scammers contact victims and claim the consumer owes money on a fictitious debt or to help recover money lost in a previous scam

Advance Fee Loans, Credit Arrangers

False promises of business or personal loans, even if credit is bad, for a fee upfront

Phishing/Spoofing

Emails pretending to be from a well-known source ask consumers to enter or confirm personal information

Computers: Equipment and Software

Scammers claim to offer "technical support" for computer problems and charge a fee to fix a nonexistent problem

Scholarships/Grants

For a fee, a "search company" offers to conduct customized search for scholarships or grants for students. Scammers take money and run or provide a worthless list

Friendship & Sweetheart Swindles

Con artist nurtures an online relationship, builds trust, and convinces victim to send money

Charitable Solicitations

Scammers contact victims claiming to represent non-existent charities (or real charities they don't actually work for) and ask for donations.



Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages or individuals following delivery trucks to see where the truck is dropping off packages.
- Please dial 911 to report crimes in progress, suspicious activity or for life threatening emergencies. If it is not an emergency, dial (415) 553-0123.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

Homeless Outreach and Outreach to Drug Users:

Taraval Station has two officers that coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.

Foot Patrols:

Taraval Station has 3 foot beat locations. These officers are assigned to Irving St, West Portal Ave and Ocean Ave.


