## Greetings All,

I want to give everyone a reminder that home burglaries continue to be an area of concern for me and all the Officers here at Taraval Station. The most common trend in home burglaries are garage burglaries.

Thieves either drill a baseball sized hole in the upper middle of a wooden garage door panel or break a window panel and then use a long wire hook to hook the emergency release cord on your garage door. Many time car antennas are snapped off a parked car and made into a hook. Thieves then manually open the door.

Secure your garage by taking off the emergency release cord making it harder to disengage your garage door. Install motion sensor lighting in the front of your garage door. If you have high value bicycles in your garage lock the bicycles with a cable or chain while stored in the garage. Additionally, lock or hide any high value items you store in your garage.

Lastly, now that you know the burglary trends, "If you see something say something".

-Compared to the same date last year, 2020; as of 03/07/21 we are currently down 10% in theft from vehicles, 14% in assaults, and 14% in robberies. However, we are up 177% in home and commercial burglaries and 9% in motor vehicle theft .

The San Francisco Police Department will conduct a Traffic Safety Enforcement Operation on **March 10th**, **17th 24th**, and **31st** with a focus on distracted driving, especially through the use of handheld cell phones and texting. Distracted driving is anything that takes your eyes or mind off the road or your hands off the steering wheel. These are some of the most dangerous things we do behind the wheel that many people do not think about because these actions are so common.

It is important to recognize the dangers of distracted driving. In California, cell phone laws were enacted to help prevent distracted driving and make roads safer. The law prohibits driving while holding a cell phone in your hand. If the cell phone is used in a hands-free manner, such as voice command or the use of a mounting device, it is completely legal. While driving, you can single swipe or tap the screen to activate or deactivate a feature or function, but you cannot text, scroll or tap multiple times. The law allows using your cell phone for emergency purposes, including, but not limited to, an emergency call to a law enforcement agency, health care provider, fire department, or other emergency services agency or entity.

Any driver under the age of 18 cannot use a cell phone or any other electronic wireless device at all (not hand -held, hands-free, Bluetooth, speakerphone, or any other means) except for the above emergency purposes.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.





# San Francisco Police Make Arrest in Firearms, Explosives Investigation 21-051

MARCH 03, 2021 | 4:23 PM

Taraval Station

On February 21, 2021 at approximately 10:05 PM, San Francisco Police officers from Southern Police Station responded to the unit block of Stillman Street regarding a report of a shot fired. Officers determined that the victim, a 42-year-old male was in the process of repossessing a 2017 Mercedes Benz when he heard a loud noise. The victim turned and saw the suspect holding a handgun. He then noticed a bullet hole in the driver's side door of the Mercedes. The victim was not injured.



The suspect retrieved items from the car and entered his residence. The victim continued to hook the Mercedes to the tow truck but then saw that the suspect was pointing an assault rifle toward him from the gated area of his building. The victim disconnected the Mercedes, fled the area, and called 911.

Officers were not able to locate the suspect and impounded the Mercedes.

On February 23, 2021 at approximately 3:04 PM, SFPD investigators from the Crime Gun Investigations Center (CGIC) and Gang Task Force (GTF), along with special agents from the Bureau of Alcohol Tobacco, Firearms and Explosives (ATF) responded to the suspect's residence to arrest the suspect and serve a search warrant. When the suspect, 31-year-old Cameron Ybarra exited his residence, SFPD officers attempted to take him into custody. Ybarra immediately resisted their efforts to take him into custody. He was armed with a handgun in his waistband. SFPD members and ATF were able to take him into custody after a struggle.

SFPD investigators and Federal agents served a search warrant at his residence and seized items including an assault rifle, privately made firearms (aka "ghost guns"), ammunition, magazines, body armor, a silencer, a "3D printer," other gun manufacturing items, fraudulent identification materials and suspected bomb making materials.

A suspicious device was also located, and the apartment building was evacuated. The SFPD Explosive Ordinance Disposal Unit (EOD) arrived and took custody of the item which was determined to be an explosive device.

Ybarra was transported to a local hospital for treatment and later booked at the SF County Jail. He was rebooked on the following charges: Carrying a Concealed Weapon (25400(a)(2) PC), Carrying a Loaded Firearm in Public (25850(a) PC), Possession of Ammunition by a Prohibited Person (30305 (a)(1) PC), Discharge of a Firearm in a Grossly Negligent Manner (246.3 (a) PC), Possession of a Silencer (33410 PC), three counts of Felon in Possession of a Firearm (29800 (a) (1) PC), Assault with a Deadly Weapon/Assault Weapon (245(a)(3) PC, Possession of an Explosive Device (18715(a)(3) PC, and Resisting, Delaying or Obstructing a Peace Officer (148(a)(1) PC).

Ybarra is on probation for a prior burglary arrest. He also has an open case in San Francisco Superior Court for a September 2019 incident in which he violently resisted arrest causing serious injury to an SFPD officer. That officer has yet to return to full duty.

# San Francisco Police Arrest Garage Burglar 21-047

FEBRUARY 25, 2021 | 11:44 AM

On December 13, 2020 San Francisco Police officers from Richmond Station responded to the 1600 block of Lyon Street for a report of a burglary. Officers met with the victim who told officers that his garage was broken into during the night and three of his bicycles were stolen. Officers obtained video surveillance, which showed three suspects forcibly enter the victim's garage, take the bicycles, and flee.

On January 1, 2021 San Francisco Police officers from Taraval Station responded to the 1500 block of 8<sup>th</sup> Avenue for a report of a burglary. Officers mt with the victims who said that at approximately 7:00 a.m. they received an alert from their security system that there was activity in their garage. The victims went to their garage, found the door open and determined that a bike was taken.

On January 30, 2021 San Francisco Police officers from Northern Station responded to the 1600 block of Bay Street regarding a burglary. Officers met with the victim who told officers that her garage was broken into during the night and a bicycle was stolen. Officers obtained video surveillance, which showed two suspects forcibly enter the victim's garage, take a bicycle, and flee.

Believing that the incidents were related the SFPD Burglary Unit took over the investigation. Investigators identified one of the suspects connected to all three incidents as 26-year-old Alberto Cauich of San Francisco. On February 9, 2021 investigators served a search warrant on the 400 block of Jones Street where Cauich was taken into custody without incident.

Cauich was later transported to San Francisco County Jail and booked on three counts of first-degree burglary (459 PC).

While an arrest has been made, this remains an open investigation. Investigators are asking anyone with information - including cell phone or surveillance camera video - regarding this incident to call the SFPD 24hour-tip line at <u>1-415-575-4444</u> or Text a Tip to <u>TIP411</u> and begin the message with SFPD.





# San Francisco Police Make Arrest in Internet Crimes Against Children (ICAC) Investigation 21-045

In January 2021 the SFPD Internet Crimes Against Children (ICAC) Unit was assigned a case involving an individual who was storing hundreds of child pornography files being stored in a cloud storage account.

The account was found to contain images of prepubescent minors being sexually abused by adults.

On February 19, 2021 SFPD investigators served search warrants at apartments located on the 1800 block of Jackson Street and the 1700 block of Clay Street, both of which were associated with the owner of the cloud account.

During the search warrant investigators were able to link the cloud storage account to one of the residents, 52-year-old Bruce Taylor.

During the investigation it was also discovered that Taylor was surreptitiously recording underage minors and other women at different locations throughout San Francisco.

Taylor was a placed under arrest for one count of possession of child pornography, one count of possession of over 600 files of child pornography involving children under the age of twelve (12), and one count of possession of child pornography involving sadomasochism.

It was determined that Taylor is a former youth lacrosse coach at a private school in San Francisco.

The charges were refiled by the San Francisco District Attorney's Office.

As of the date of this news release, Taylor remains in custody.

# San Francisco Police Request Public Assistance in Locating Stolen Maltese Puppy 21-048

FEBRUARY 25, 2021 | 4:58 PM

On February 22, 2021 at approximately 12:29 PM, San Francisco Police officers from Central Police Station responded to the 200 block of Sutter Street regarding an auto burglary and theft of a dog. The victim, a 23-year-old Los Gatos resident, told officers that he parked his Subaru SUV at approximately 10:00 AM, leaving his 4-month-old Maltese puppy, "Scruggs" inside the car. The victim returned about 30 minutes later and discovered that an unknown suspect had stolen Scruggs.

Through the course of an investigation which included surveillance video, the suspect was identified as 43-year-old Viengphet Sasone.

On February 25, 2021 at approximately 12:50 PM, SFPD officers took Sasone into custody on the 500 block of Mason Street. Sasone refused to tell investigators where Scruggs was located.

Sasone was later booked into the SF County Jail on the following charges: Auto Burglary, 2nd Degree (459 PC), Possession of Burglar Tools (466 PC) and a probation violation (1203.2(a) PC. Sasone is on probation in San Francisco County for a prior burglary offense.

SFPD Investigators are appealing to the public for assistance in locating Scruggs, ensuring his health and safety, and returning him to his family. Scrugss is a white, Maltese puppy, weighing approximately 12 pounds and last seen wearing a pink and blue leash/harness. His photo accompanies this news release.

#### **Domestic Violence**

Domestic violence and abuse involve people in a relationship, whether they're married, living together, dating, separated, LGBTQ+ or straight. Domestic violence and abuse can include psychological mistreatment such as name-calling or insults, stalking and harassing behavior, isolating a partner in the home, withholding money or outright assault.

-Remember: Domestic violence is never okay. It is not your fault and help is available.

You can also talk to your doctor. Most healthcare providers are trained to report domestic abuse and offer help to the victims. Be aware that they are also required by law to report such crimes.

### San Francisco police are here to help

The SFPD Special Victims Unit (SVU) is located at 850 Bryant Street, fifth floor, and is open Monday through Friday, 8:00 AM to 5:00 PM, <u>1-415-553-9225</u>. We investigate all felony arrest cases involving domestic abuse against minors and adults and bring cases to the District Attorney's office for prosecution. We also investigate cases in which arrests have not been made. If you are a victim in a case in which there has been no arrest, we will call to advise you on your next steps and what services may be available. Please remember to notify us if you do not want us to leave a message. The SFPD works closely with <u>La Casa de las Madres</u>. La Casa offers crisis response and support services including counseling and shelter to domestic violence victims.

Under CA Family Code § 6228, incident reports requested by a victim or their representative for the alleged crimes of domestic violence, sexual assault, stalking, human trafficking, and abuse of an elder or dependent adult are entitled to receive copies within five working days of the request, unless good cause for delay exists. If good cause exists, reports shall be released no later than ten working days after request is made. Contact SFPD's Crime Information Services Unit (CISU) at <u>1-415-575-7232</u> for assistance.

#### Elder Abuse

Elder abuse can take many forms. It can include physical abuse, emotional abuse, neglect, abandonment, sexual abuse or financial abuse. The abusers may be the elders' family members or caregivers.

#### Warning signs of elder abuse

- Depression or confusion
- Unexplained bruises, burns, or scars
- Weight loss for no apparent reason
- Signs of trauma, such as rocking back and forth
- Agitated, violent or seems withdrawn
- Disheveled, with unwashed hair or dirty clothes
- Bed sores or other preventable conditions
- Recent or sudden financial loss

If you are an elder who is being mistreated or you know an elder showing signs of abuse, call:

The SFPD SVU investigates all felony arrest cases involving abuse and neglect involving someone 65 years or older or a dependent adult between the ages of 18 and 64. We also review non-arrest and misdemeanor cases and send them to the District Attorney if warranted. SVU is located at 850 Bryant Street, fifth floor, and is open Monday through Friday, 8:00 AM to 5:00 PM, <u>1-415-553-9225</u>.

The San Francisco Police Department would like to remind the public to stay safe and help protect yourself from vehicle and home burglaries. Below are some simple steps you can take to help prevent your home or vehicle from being burglarized.

- Do not leave valuables in your vehicle
- Remove garage door opener from your vehicle if parked outside your garage
- Lock the door from your garage leading inside your home
- "Block the cord" garage door openers have an emergency release cord that, when pulled, disconnects the door from the mechanism thereby making it easy for burglars to enter your garage

# PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.



# **ALWAYS CLOSE YOUR** GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



## **INSTALL SURVEILLANCE** CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.

# HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.

# **INSTALL MOTION-SENSITIVE** LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.

# **TIE EMERGENCY RELEASE CORD**

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



# SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



## INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

Use USPS special services like Signature Confirmation or Registered Mail to add a layer of security.

# CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

### DELIVER TO SECURE LOCATIONS Send packages to secure locations such as

Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

#### REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

# SF SAFE CITY CAMERA PROGRAM



Through the SF SAFE City Camera Program, we address public safety needs and help reduce crime through collaboration.

By partnering with community stakeholders, such as local merchant associations, businesses, and community residents from San Francisco's high trafficked neighborhoods, commercial corridors, and our City government, we identify specific needs, install public safety cameras and create, develop, and implement safety plans with a meaningful community-led and community-driven process.

Through this program, SF SAFE targets high-risk and high-traffic city blocks comprising about 20-30 businesses or residential areas for the installation of high definition security cameras and surveillance technology. Typically, a coverage area of about 18-24 camera views per corridor is provided. Camera installation projects for commercial corridors take about 12 weeks from start to finish and encompass outreach, assessment, mapping and system installation. We work with technology vendors as the technology solutions and data privacy provider for this program, accountable to the most stringent level of self-imposed policy standards.

In addition to the security cameras acting as a visible crime deterrent, the footage is an extraordinary tool in assisting businesses and community members in the investigation of criminal activity if/when any occur. This program levels the playing field, holding all involved accountable, creating an equitable and true evidence chain for investigators and public defenders alike, as an innovative alternative policing tool empowering communities to take ownership over their own public safety needs.

# **Crime Definitions**

**Robbery** – The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery** - (Misdemeanor battery) is any willful and unlawful touching of another. (Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

\*Assault is when a person swings their arm and **battery** is when that arm makes contact with another person.

Aggravated Assault – An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

# Department Published Reports

## Use of Force, Stops & Arrests

The Quarterly Report on Arrests, Uses of Force and Stop Data is published quarterly per section 96.A.3 of the San Francisco Administrative Code.

## **Firearms Discharges**

Every time an officer discharges their weapon, no matter the circumstance, the Department convenes the Firearms Discharge Review Board (FDRB) per DGO 3.10. The FDRB meets as needed quarterly, and findings of the FDRB are presented to the San Francisco Police Commission.

## Early Intervention System

The San Francisco Police Department's Early Intervention System (EIS) is a structured system that identifies and manages behaviors that result in performance related problems by individual members. The EIS system, per DGO 3.19, is a non-disciplinary intervention to assist members in professional development. EIS publishes reports quarterly.

# Officer Involved Shootings (OIS) Historical Data

#### Officer Involved Shootings, Suspect-Involved, 2009 - 2019

SFPD updates the yearly statistics for the Officer Involved Shootings (OIS) Historical Data each year in February for the prior year.

# Memorandum of Understanding (MOU) between the San Francisco District Attorney's Office and the San Francisco Police Department

The MOU outlines the agreement between the San Francisco District Attorney's Officer and the San Francisco Police Department regarding the procedures for the criminal investigation of "Covered Incidents" to determine if an officer committed a criminal offense.

## **Historical Traffic Stops Reports**

The Department previously used eStop to collect information on traffic stops. On July 1, 2018, the Department discontinued the use of eStop and began using the State of California's Stop Data Collection System (SDCS). Current stop data collection can be found in the quarterly 96a Use of Force/Encounter Report for the correlating quarter.

# **Definition of Suspicious Activity**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

#### Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages or individuals following delivery trucks to see where the truck is dropping off packages.
- Please dial 911 to report crimes in progress, suspicious activity or for life threatening emergencies. If it is not an emergency, dial (415) 553-0123.



# **Definition of Community Policing**

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

#### Homeless Outreach and Outreach to Drug Users:

Taraval Station has two officers that coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.

#### Foot Patrols:

Taraval Station has 3 foot beat locations. These officers are assigned to Irving St, West Portal Ave and Ocean Ave.

#### Monthly Police Community Relations Meetings:

Monthly community meeting are currently on hold due to the current situation, we will update everyone with the date and location of our next meeting. Stay tune for more info.

You may also contact a department supervisor at any SFPD police station. <u>Each station</u> is open 24 hours a day. SFPD personnel are required to receive complaints courteously and to assist you with filing them.

## How to Describe a Suspect

Providing a detailed description of a criminal suspect can help solve crimes in San Francisco. Suspects can easily change their appearance with a hat, jacket or glasses. It is important to be mindful of unique characteristics such as body markings, tattoos, shoes and specific clothing markings, like logos.

### Note the Following Unique Characteristics:

Race	Sex	Age	_Height	Weight	
Hair	Eyes	Complexion_			
<ul> <li>Physical Characteristics (slight or heavy build, scars, marks, tattoos, manner of walk, mustache, glasses)</li> </ul>					

- Clothing (type and color, logos or brand names, shoes, jewelry, accessories)
- Weapon (type of weapon used by the suspect: rifle, shotgun, automatic, revolver, knife)
- · Remarks (note anything the suspect says, accent, any names used)
- Means of Escape (vehicle or foot, license plate number, year, make, model, color, traveling in which direction)

If it's safe, take a photo of the suspect, vehicle, license plate number, etc.

# What to Do During an Emergency

## How to Call 911 in an Emergency

- ☑ Remain Calm and Dial 911 Immediately
  - WHEN to Dial 911
    - · If a crime is posing an immediate threat to you or others
    - · If there is a medical emergency
    - · If the incident is in progress
    - · If the incident just occurred and you know where the suspect is
- ☑ State the following information:
  - WHERE the incident is happening and WHAT is occurring,
  - for example: "I'm at 1234 Market Street and I've just been robbed"
  - · Tell the operator if you are in immediate danger or are being threatened
  - Be brief, clear and accurate
- As long as it is safe, stay on the line and answer the operator's questions
- Describe each suspect separately from head to toe (see more information on the back of this card)

### Dispose of Unwanted and Expired Medication at Taraval Station

There is a secured bin at Taraval Station where you can dispose of unwanted and expired medication at any time of the day or night. The bin will accept any type of prescription and off the shelf medication.

When disposing the medication, please leave it in the original container with your personal information crossed out or removed. You can also place the medication into a clear plastic zip top bag-
