#### Hello everyone,

Recently I have been reading more reports that have come across my desk about attempted home burglaries. I mention this because these incidents were attempts and the criminal act of burglary was not completed.

We have been messaging this for a while now about the importance of securing your garage door at night when you are home and especially when you are away from home. Many people have been securing the emergency release cord on their garage doors by tying the cord up so thieves cannot easily break a window or drill a hole on your garage door then hook the emergency release cord and disengage you garage door.

Some people have also installed an additional locking latch as an extra layer of security and I am now seeing more thieve being deterred. Keep up the good work of securing your garage door. Exterior motion lighting is also a great idea.

Residential garage burglaries are by far the most notable increase in crime in the Taraval Police District so being vigilant and securing your garage door is a smart way to deter crime in our community.

-Compared to the same date last year, 2020; as of 05/23/21 we are currently down 27% in theft from vehicles and 10% in robberies. However, we are up and 5% in assaults, 99% in home and commercial burglaries and 12% in motor vehicle theft .

- Contact police or dial 9-1-1 立即聯繫當地執法部門
- Detail what happened (when, where, what, why, who) What exactly was the hate language? Use same words.
  Write it down.

- Detail suspect and witnesses- the who: Known (contact info?) or unknown. What did they look like (i.e. gender, race, height, clothes, identifying tattoos/piercings, etc.) 詳細記下疑犯和證人: 是你認識的嗎? 性別,種族,身高,衣服,刺青紋身和 耳洞等

On May 15, 2021, at approximately 10:08 am, San Francisco Police officers from Bayview District Police Station responded to the area of 25th and Connecticut Streets regarding a shooting. Upon arrival, officers located a 61-year-old male victim suffering from apparent gunshot wounds. Officers rendered aid and summoned an ambulance. The victim was transported to a local hospital where he later succumbed to his injuries.

On May 15, 2021, at approximately 12:26 pm, San Francisco Police officers were in the area investigating the earlier homicide when they responded to a report of shots fired on the unit block of Dakota Street. Officers located two adult males suffering from gunshot wounds. The victims, ages 49 and 54, were transported to a local hospital. Despite lifesaving efforts, the 54-year-old victim succumbed to his injuries. The 49-year-old victim remains hospitalized.

Investigators from the SFPD Homicide Detail took over both investigations and identified 32-yearold Robert Newt as the suspect in both incidents. There are three warrants for Newt's arrest, two for murder and one for attempted murder. Newt is considered armed and extremely dangerous. Newt is known to frequent the Bayview-Hunter's Point area. A photo\* of Robert Newt accompanies this news release.

If you see Newt do not approach him. Note his location, clothing, and any vehicle description and immediately call 9-1-1.

# Auto Burglary Investigation Leads to Officer-Involved Shooting (Town Hall Notes) 21-091(a)

MAY 13, 2021 | 3:57 PM

The following information is based on a preliminary and ongoing investigation, which continues to evolve as investigators interview witnesses, review physical and electronic records, and analyze forensic evidence. The Department's understanding of the facts and circumstances may change as additional evidence is collected and analyzed.

#### **Incident Narrative**

The officer-involved shooting (OIS) incident that occurred on May 7, 2021, at Varney Place and Jack London Alley was preceded by six separate incidents. The incidents consist of:

• Five (5) auto burglaries, which occurred from approximately 11:44 a.m. to 12:45 p.m. in the Richmond and Central Police Districts of San Francisco; and


• One (1) instance during which the Suspect vehicle fled from a neighboring police agency during a traffic stop attempt.

The OIS incident discussed in this presentation involves plainclothes members of the San Francisco Police Department assigned to the Central Police District. The plainclothes officers were conducting an auto burglary surveillance and arrest operation when the OIS occurred: The precise chronology of these incidents is currently under investigation. The times presented are approximate.

The following is a summary of the events as they are understood as of today, Thursday, May 13th, 2021: At approximately 11:44 a.m., witnesses observed an auto burglary near the Japanese Tea Garden. This location is within Golden Gate Park in the Richmond Police District of San Francisco. The suspect vehicle was described by witnesses as a silver Mitsubishi Eclipse Cross. A license plate was provided and later deemed to be stolen. The suspects were observed breaking a vehicle window, stealing bags from the vehicle, and fleeing the scene in the Mitsubishi.

At approximately 12:04 p.m., the U.S. Park Police observed the same silver Mitsubishi in the Presidio area of San Francisco. U.S. Park Police Officers attempted to make a traffic stop of the vehicle. However, the vehicle accelerated at a high rate of speed, drove over a median into oncoming traffic, and fled the area driving the wrong way. U.S. Park Police subsequently called Central Police Station and notified the Central plainclothes officers of the traffic stop attempt and the evasive maneuvers by the suspect vehicle's driver.

At approximately 12:10 p.m., a witness observed an auto burglary at Leavenworth and Jefferson Streets in the Central Police District. The witness in this incident heard glass break, and observed a suspect enter a vehicle window and retrieve a purse and bag. The suspect then entered a silver Mitsubishi, which left the area. The vehicle had the same license plate as the vehicle described in the Golden Gate Park auto burglary.



MAY 13, 2021 | 3:57 PM

At approximately 12:20 p.m., an auto burglary occurred at Pier 35 in the Central Police District. A witness described observing the occupant of a silver Mitsubishi enter a vehicle and steal luggage before fleeing in the Mitsubishi. A witness flagged down a passing University of California Police Department officer, who later reported this information to SFPD.

At approximately 12:31 p.m., the Department of Emergency Management (DEM) broadcast information about a silver Mitsubishi with the same license plate number as those previously reported "casing vehicles" in the area of Pier 35. ("Casing" is a term commonly used to describe suspicious behavior of suspects loitering near vehicles for the purpose of committing auto burglary.)

As a result of this broadcast, and their knowledge of prior incidents, plainclothes officers from Central Station began searching the Embarcadero area for the silver Mitsubishi. At approximately 12:35 p.m., two plainclothes officers observed the silver Mitsubishi driving southbound on Embarcadero approaching Washington Street. The Officers conducted mobile surveillance of the vehicle and its occupants to observe their actions. The Officers observed the occupants of the Mitsubishi case a parked vehicle near Washington and Drumm Streets. The officers momentarily lost sight of the suspects and then saw them remove bags and items from the parked vehicle. The suspects got back into the silver Mitsubishi, which then drove away from the area.

At approximately 12:40 p.m., plainclothes officers resumed their observation of the Mitsubishi and its occupants. The vehicle continued southbound on Embarcadero and was seen double parked near an Audi, which was parked on the street. The officers briefly lost sight of the Mitsubishi as it parked near the Audi. The officers then drove by shortly after and observed that the Audi had been burglarized near where the Mitsubishi had been double parked.

Plainclothes officers once again began searching the area to locate the silver Mitsubishi. At approximately 12:48 p.m., two plainclothes officers — while searching the area of Jack London Alley and Varney Place — observed the Mitsubishi. The Mitsubishi was pulled to the side of the alley against a building, and two vehicle occupants were out of the vehicle. The two suspects were observed removing bags, luggage, and other items from the vehicle. The suspects appeared to be searching and emptying the bags and luggage onto the ground.

The plainclothes officers exited their vehicle and began observing the actions of the suspects from the corner of Jack London Alley and Varney Place. One of the suspects, later identified as Xavier Pittman Jr., was seen wearing a black ski mask, grey sweatshirt, black t-shirt, blue pants, and black shoes.

The plainclothes officers ran towards Mr. Pittman with their firearms drawn to place him under arrest. A surveillance video shows plainclothes officer #1 grabbed Mr. Pittman, and both fell to the ground. During the physical contact with Mr. Pittman, an officer-involved shooting occurred, which resulted in one round striking Mr. Pittman in the left wrist area.

The audio portion of a video recording recovered from the scene captured one of the officers yell, "Police!" — immediately followed by a single gunshot. Mr. Pittman can be heard on the audio saying that he had been shot and requesting an ambulance.

The silver Mitsubishi accelerated away at a high rate of speed with the rear hatchback still open. The suspect vehicle collided with a stopped and occupied vehicle as it proceeded west on Varney Place. The suspect vehicle was last seen on video fleeing northbound on 3rd Street. An officer broadcast a request for an ambulance and additional resources to the scene. Officers rendered medical aid to Mr. Pittman. An ambulance arrived and transported Mr. Pittman to a local hospital.

#### Additional Information

Mr. Pittman's Condition

• Mr. Pittman was treated for non-life-threatening injuries at a local hospital.

#### Evidence

• Based upon information known at this time, Mr. Pittman was not in possession of a weapon at the time of the incident.

• Preliminary evidence indicates that one officer fired one (1) round from his department-issued firearm. The second officer on the scene did not fire his department-issued firearm.

• A large amount of stolen property related to the auto burglaries was recovered at the scene. • The Mitsubishi was recovered unoccupied in Oakland, California.

#### Video

• The plainclothes officers involved in this incident were not wearing body-worn cameras (or BWCs). Current San Francisco Police Department Policies allow BWC exemptions for officers working certain plainclothes operations. This particular operation met the BWC exemptions.

• Nearby businesses provided surveillance video of various portions of this incident.

• Additional video is being sought by investigators.

• Witnesses to the OIS incident have been interviewed.

- o 496(a) PC Possess Stolen Property (Felony, 1 count)
- o 12022.1 PC Committing a Felony while on release (Felony, 1 count)

#### **Domestic Violence**

Domestic violence and abuse involve people in a relationship, whether they're married, living together, dating, separated, LGBTQ+ or straight. Domestic violence and abuse can include psychological mistreatment such as name-calling or insults, stalking and harassing behavior, isolating a partner in the home, withholding money or outright assault.

-Remember: Domestic violence is never okay. It is not your fault and help is available.

You can also talk to your doctor. Most healthcare providers are trained to report domestic abuse and offer help to the victims. Be aware that they are also required by law to report such crimes.

#### San Francisco police are here to help

The SFPD Special Victims Unit (SVU) is located at 850 Bryant Street, fifth floor, and is open Monday through Friday, 8:00 AM to 5:00 PM, <u>1-415-553-9225</u>. We investigate all felony arrest cases involving domestic abuse against minors and adults and bring cases to the District Attorney's office for prosecution. We also investigate cases in which arrests have not been made. If you are a victim in a case in which there has been no arrest, we will call to advise you on your next steps and what services may be available. Please remember to notify us if you do not want us to leave a message. The SFPD works closely with <u>La Casa de las Madres</u>. La Casa offers crisis response and support services including counseling and shelter to domestic violence victims.

Under CA Family Code § 6228, incident reports requested by a victim or their representative for the alleged crimes of domestic violence, sexual assault, stalking, human trafficking, and abuse of an elder or dependent adult are entitled to receive copies within five working days of the request, unless good cause for delay exists. If good cause exists, reports shall be released no later than ten working days after request is made. Contact SFPD's Crime Information Services Unit (CISU) at <u>1-415-575-7232</u> for assistance.

#### Elder Abuse

Elder abuse can take many forms. It can include physical abuse, emotional abuse, neglect, abandonment, sexual abuse or financial abuse. The abusers may be the elders' family members or caregivers.

#### Warning signs of elder abuse

- Depression or confusion
- Unexplained bruises, burns, or scars
- Weight loss for no apparent reason
- Signs of trauma, such as rocking back and forth
- Agitated, violent or seems withdrawn
- Disheveled, with unwashed hair or dirty clothes
- Bed sores or other preventable conditions
- Recent or sudden financial loss

If you are an elder who is being mistreated or you know an elder showing signs of abuse, call:

The SFPD SVU investigates all felony arrest cases involving abuse and neglect involving someone 65 years or older or a dependent adult between the ages of 18 and 64. We also review non-arrest and misdemeanor cases and send them to the District Attorney if warranted. SVU is located at 850 Bryant Street, fifth floor, and is open Monday through Friday, 8:00 AM to 5:00 PM, <u>1-415-553-9225</u>.

The San Francisco Police Department would like to remind the public to stay safe and help protect yourself from vehicle and home burglaries. Below are some simple steps you can take to help prevent your home or vehicle from being burglarized.

- Do not leave valuables in your vehicle
- Remove garage door opener from your vehicle if parked outside your garage
- Lock the door from your garage leading inside your home
- "Block the cord" garage door openers have an emergency release cord that, when pulled, disconnects the door from the mechanism thereby making it easy for burglars to enter your garage

# PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.



#### **ALWAYS CLOSE YOUR** GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



#### **INSTALL SURVEILLANCE** CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.

### HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.

#### **INSTALL MOTION-SENSITIVE** LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.

#### **TIE EMERGENCY RELEASE CORD**

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



#### SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



#### INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

#### USE SPECIAL SERVICES

Use USPS special services like Signature Confirmation or Registered Mail to add a layer of security.

#### CUSTOMIZE DELIVERIES



### SF SAFE CITY CAMERA PROGRAM



Through the SF SAFE City Camera Program, we address public safety needs and help reduce crime through collaboration.

By partnering with community stakeholders, such as local merchant associations, businesses, and community residents from San Francisco's high trafficked neighborhoods, commercial corridors, and our City government, we identify specific needs, install public safety cameras and create, develop, and implement safety plans with a meaningful community-led and community-driven process.

Through this program, SF SAFE targets high-risk and high-traffic city blocks comprising about 20-30 businesses or residential areas for the installation of high definition security cameras and surveillance technology. Typically, a coverage area of about 18-24 camera views per corridor is provided. Camera installation projects for commercial corridors take about 12 weeks from start to finish and encompass outreach, assessment, mapping and system installation. We work with technology vendors as the technology solutions and data privacy provider for this program, accountable to the most stringent level of self-imposed policy standards.

In addition to the security cameras acting as a visible crime deterrent, the footage is an extraordinary tool in assisting businesses and community members in the investigation of criminal activity if/when any occur. This program levels the playing field, holding all involved accountable, creating an equitable and true evidence chain for investigators and public defenders alike, as an innovative alternative policing tool empowering communities to take ownership over their own public safety needs.

# **Crime Definitions**

**Robbery** – The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery** - (Misdemeanor battery) is any willful and unlawful touching of another. (Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

\*Assault is when a person swings their arm and **battery** is when that arm makes contact with another person.

Aggravated Assault – An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.







### Department Published Reports

#### Use of Force, Stops & Arrests

The Quarterly Report on Arrests, Uses of Force and Stop Data is published quarterly per section 96.A.3 of the San Francisco Administrative Code.

#### **Firearms Discharges**

Every time an officer discharges their weapon, no matter the circumstance, the Department convenes the Firearms Discharge Review Board (FDRB) per DGO 3.10. The FDRB meets as needed quarterly, and findings of the FDRB are presented to the San Francisco Police Commission.

#### Early Intervention System

The San Francisco Police Department's Early Intervention System (EIS) is a structured system that identifies and manages behaviors that result in performance related problems by individual members. The EIS system, per DGO 3.19, is a non-disciplinary intervention to assist members in professional development. EIS publishes reports quarterly.

#### Officer Involved Shootings (OIS) Historical Data

#### Officer Involved Shootings, Suspect-Involved, 2009 – 2019

SFPD updates the yearly statistics for the Officer Involved Shootings (OIS) Historical Data each year in February for the prior year.

The MOU outlines the agreement between the San Francisco District Attorney's Officer and the San Francisco Police Department regarding the procedures for the criminal investigation of "Covered Incidents" to determine if an officer committed a criminal offense.

#### **Historical Traffic Stops Reports**



# **Definition of Suspicious Activity**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

#### Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages or individuals following delivery trucks to see where the truck is dropping off packages.
- Please dial 911 to report crimes in progress, suspicious activity or for life threatening emergencies. If it is not an emergency, dial (415) 553-0123.



# **Definition of Community Policing**

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

#### Homeless Outreach and Outreach to Drug Users:

Taraval Station has two officers that coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.

#### Foot Patrols:

Taraval Station has 3 foot beat locations. These officers are assigned to Irving St, West Portal Ave and Ocean Ave.

#### Monthly Police Community Relations Meetings:

Monthly community meeting are currently on hold due to the current situation, we will update everyone with the date and location of our next meeting. Stay tune for more info.




The DPA is located at 1 South Van Ness Ave., 8th Floor, San Francisco, CA 94103.

#### How to Describe a Suspect

Providing a detailed description of a criminal suspect can help solve crimes in San Francisco. Suspects can easily change their appearance with a hat, jacket or glasses. It is important to be mindful of unique characteristics such as body markings, tattoos, shoes and specific clothing markings, like logos.

#### Note the Following Unique Characteristics:

- Clothing (type and color, logos or brand names, shoes, jewelry, accessories)
- Weapon (type of weapon used by the suspect: rifle, shotgun, automatic, revolver, knife)
- · Remarks (note anything the suspect says, accent, any names used)
- Means of Escape (vehicle or foot, license plate number, year, make, model, color, traveling in which direction)

If it's safe, take a photo of the suspect, vehicle, license plate number, etc.

# What to Do During an Emergency

#### How to Call 911 in an Emergency

- Remain Calm and Dial 911 Immediately
  - WHEN to Dial 911
    - · If a crime is posing an immediate threat to you or others
    - · If there is a medical emergency
    - · If the incident is in progress
    - · If the incident just occurred and you know where the suspect is
- ☑ State the following information:
  - WHERE the incident is happening and WHAT is occurring,
  - for example: "I'm at 1234 Market Street and I've just been robbed"
  - · Tell the operator if you are in immediate danger or are being threatened
  - Be brief, clear and accurate
- As long as it is safe, stay on the line and answer the operator's questions
- Describe each suspect separately from head to toe (see more information on the back of this card)





#### Dispose of Unwanted and Expired Medication at Taraval Station

There is a secured bin at Taraval Station where you can dispose of unwanted and expired medication at any time of the day or night. The bin will accept any type of prescription and off the shelf medication.

When disposing the medication, please leave it in the original container with your personal information crossed out or removed. You can also place the medication into a clear plastic zip top bag-

gies. Contact the front desk officer and inform them that you want your medication dispose of. The officer will assist you. Please note that once an item that had been disposed of inside the bin, we cannot retrieve it. So make sure your ring, cell phone or anything of value is not accidentally disposed of.
